The safety and comfort of students is a real concern to the Roseville Board of Education. Be assured that we intend to make the time each child spends riding a school bus a pleasant experience for the child, the other students, and the drivers.

The School Bus Safety Rules described here are designed as a guide for parents and students.

Parent Responsibility:

It is the parent's responsibility to supervise their children at the bus stop and take the temperature of the child each morning. Roseville Community Schools provides transportation, not supervision. If your child has special needs or allergies like Bee sting allergies, Peanut allergies, Diabetic, Epilepsy, Hemophiliac or blindness or other medical problems please call our office. The bus drivers need to have a record of this in case of emergency.

Bus conduct

Student Responsibility:

1. To know the time and place where to board the bus.
2. To occupy the seat or area of the bus assigned by the driver.
3. Must put hand sanitizer on hands before going to their seat on the bus. Wear a mask.
4. To obey the rules and instructions of the driver.
5. To keep hands and head inside the bus at all times.
6. To keep the bus clean. No food may be eaten on the bus.
7. No smoking or vaping at anytime.
8. Actions such as obscene language, or gestures, swearing, fighting, pushing, throwing objects inside or outside the bus, abusing the driver or other riders and/or the property of others, may result in the student being prohibited from riding the bus.
9. Secondary students **MUST** have a student I.D. in order to ride the bus.

RESULTS OF MISBEHAVIOR

First Offense:

The principal will counsel the student, alert the parent, and consider other possible action.

Second Offense:

The principal will notify the parent and mail a confirming report that the student has been removed from the bus for three days.

Third Offense:

The student will be removed from the bus for one week or longer and/or up to the remainder of the school year if necessary.

Some Additional Tips:

1. Be careful going to the bus stop. Where there is no sidewalk, walk on the left, facing traffic, single file.
2. Wait far enough back from the shoulder of the road so you are not in danger of falling into the path of the bus or other vehicles. Wait in an orderly group, watching out for younger children.
3. Be on time! Help keep the bus on schedule.
4. Let the younger children get on first. Form a single line when getting on, and use the handrail.
5. If crossing the street to board the bus, wait for a signal from the driver.
6. Please be advised that your child may be video taped and voice recorded when being transported.
7. We will provide hand sanitizer and masks if you want your child to have one.
